**The Course:** is approx. 6-8 miles and is the same for all divisions.

**Hedge Hopper Division:** Jumping Division at a faster Hunt Pace, based on all jumps being taken.

**Hill Topper Division:** Pick n Choose Jumps at a pace slightly slower than the Hedge Hoppers.

**Trail Bopper Division:** A leisurely pace through the course.

**Attire:** Safety helmet and heeled riding boots required.

**Awards:** Winners will be those closest to the Official Optimal Pace Time.

**Teams:** may consist of 2-3 riders. Three ribbons will be available for the top six places of finish for all divisions.

**Refreshments:** will be available and provided by the Woodville Trailbusters 4-H club. Donations to their club are accepted and greatly appreciated.

**Liability Waivers:** must be signed by all participants. All Waivers for riders under the age of 18 MUST be signed by a parent or legal guardian. A trainer or chaperon is not a legal guardian.
